WCD intends to update the statute reference in OAR 436-060-0005(19) to ORS 656.005(27) when filing notice of permanent OAR 436-060 rules, projected to be effective January 1, 2023 and January 1, 2024, with the Secretary of State.

Fred Bruyns:

Good morning and welcome. This is a public rulemaking hearing.

My name is Fred Bruyns, and I’ll be the presiding officer for the hearing.

The time is now 10:01 a.m. on Monday, Nov. 28, 2022. We are conducting this hearing from the Conference Room F in the Labor & Industries Building in Salem, Oregon. However, we are also doing so virtually, by video and telephone conferencing. We are making an audio recording of the hearing.

The Workers’ Compensation Division of the Department of Consumer and Business Services proposes to amend chapter 436 of the Oregon Administrative Rules, specifically:

- Division 030, Claim Closure and Reconsideration,

There was a law change recently, and we did not notice it until just a few days ago, so we thought this would be a great opportunity just to correct the citation. But, have a look at that on our website if you'd like.

We are now ready to receive public testimony.

Is there anyone who is – we have no one in the conference room with us currently, but is there anyone online with us this morning who would like to testify at this time?
