I am no more comfortable being call a THEY/THEIR/THEM then I would be an IT. I find it offensive and vulgar. I have always respected my transgendered friends and observed their preferred pronoun, and they have respected mine. Why does anyone feel that taking away my femininity and PERSONAL pronoun is ok?

"Additionally I refuse to document a single person as a they in medical records. Seven years from now when I do to court to discuss my report I don't want to have to explain why I discussed an individual as a group, additionally it becomes very muddy when personal pronouns are made generic."

Response: Thank you for your testimony. We agree with your position regarding how you should be addressed personally. However, the workers' compensation rules are applicable to everyone – to men and to women and to those who identify as nonbinary. We also agree that there is potential ambiguity in using pronouns that often refer to more than one person.

Therefore, where "they" or "them" might have caused confusion, we have eliminated the pronouns and simply repeated "the worker," "the physician," etc. Regardless, these revisions will not affect your documentation in medical records. The rules will be adopted as proposed*.
