Subject: Re: DRAFT Minutes of meeting on workers' compensation rules posted

One thing I did not point out, because rules are still developing, is that with the bill we passed this year, we will no longer have a supervising physician or supervising agreement. We will have a collaboration agreement that is legally specific in spelling out that any collaborating physician is not legally responsible for the PA and not a supervisor of the PA. The point of the agreement is to document that the PA has at least one other provider to collaborate with. The agreement can be with the employer and not with a specific person as long as the employer lists the means available to the PA for collaboration as needed. If the agreement is with the employer, the employer must employ at least one physician, but that physician does not have to be the collaborating provider.

So I would suggest adding PA as you have suggested perhaps followed by the language that if a PA has a collaboration agreement with a physician then the physician must also be on the panel. Otherwise, since the physician by law is spelled out as not being responsible for or a supervisor of the PA, another option is to leave it as you have it.
